RAPID BAY - A Labor government would fund the restoration and reopening of the Rapid Bay Jetty.

This was the assurance given to the National Party's Karlene Maywald by Labor Minister for Infrastructure Patrick Conlon.

Mrs Maywald joined Nationals candidate for Finniss, Kym McHugh, last week at Rapid Bay to make the announcement.

"The jetty's current condition is the result of many years of neglect and I am pleased to have secured this commitment," Mrs Maywald said.

She said the environmental impact assessment of the jetty, together with an engineering report, had provided a number of restoration options.

However, neither Mrs Maywald or Mr McHugh elaborated on the options.

"The work will be funded


